BHIB have provided a quote of £676.66 plus tax and £25 admin fee.

A three year deal was agreed in 2021, and base price is the same as the last two previous years. Deal will come to an end next year.

31/23. Project Reports

Traffic Calming Project

As BPC have still not had a quotes or response from NNC Highways, it was noted BPC could technically employ an independent consultant and contractor but this action could result in additional costs swallowing up s106 funds.

It was agreed Cllr Scouse would contact Cllr John Currall to set up a face to face meeting with Graeme Kane and Phillip Beecroft. If there is no response or lack of satisfactory outcome, BPC will complain to the ombudsman.

Memorial Garden Project

BPC are still waiting on NNC clearing the shrubs. It was noted that Dave Lane has moved to a different role. It was agreed, the memorial tree needs extra watering now the weather is getting warmer. Action: Clerk to contact Sarah Parr

Pocket Park

Cllr Scouse had an onsite meeting with Castletree to quote for the new gravel pathway and rail at the back of the pond. They adopted a different approach and suggested digging up and having a raised path instead of lowering the ground and filling. Quote yet to be received. It was noted by Cllr Rose that the other contractor who quoted, was concerned that if you raised the path, it will disperse quicker.

Cllr Scouse contacted Pondlife for some advice on planting, but waiting on a reply. Wildlife Trust will also be contacted.

As the throw rope near the pond was stolen this month, it is estimated to cost around £32 to replace. Action: Clerk to order and share on FB, how much it has cost the community.

Cllr Scouse highlighted the recent flooding in Gate Lane. A discussion ensued and all agreed that this is not unusual but the rain was exceptional this time. There was concern that the culvert which should take the water from the brook behind Brookhaven, under Gate Lane and discharge in the other brook on the other side of the road, might be blocked or congested. Cllr Scouse and Shrive will investigate and contact Anglian water.
