General interest items - There are large potholes on the slip road coming off Kettering Road and entering into Northampton Road. **Action: Clerk to report. – lan Boyes contacted as FixMyStreet was not working. Update Oct:** Some repairs have been completed but the holes within the white lines have not. **Update Dec – Clir Scouse has contacted lan Boyes**

Update Oct: Clerk chased but works have not yet been completed. **Action: Clerk to chase again. Update Nov:** This report has been assessed and a job for repair has been raised. Initial report was raised on 22nd August. **Closed.**

22/90. General interest items. There is still a fence down which was caused by the storms in the High Street park. Update Dec: The clerk spoke to Dave Lane who advised the resident to contact their Housing Association who would be responsible for the repair.

Action: Cllr Rose to talk to Red Lion as it maybe their table left over from the jubilee celebrations. Update: Cllr Currall advised that a pavement license is not needed as the Red Lions tables sit on private land. Closed.

Clerk report

In November, the clerk was asked to report the litter bin which is in poor condition on Wellingborough Rd/Northampton Rd to waste services asking for it to be replaced. NNC Street Cleansing manager replied that due to budget constraints, they were unable to replace any litter bins at the moment but were happy to supply a quotation to supply and install, if the parish council would like to pay for this. The quote received for a new litter bin was £249 and to remove and reset - £145.

A resident contacted the clerk as they had fallen over after visiting a neighbour in Oak Close. This street lights were not working at the time and it was very dark. The Clerk reported this to the streetlighting department. A map of the numbered street lights was produced and included in the Broughton newsletter to encourage residents to report failed lighting in their streets.

The clerk and chair were in correspondence with NNC in regards to the Christmas lights outside the bungalows and on the High Street Rec not being turned on.

It emerged that the lights outside the bungalows had snapped. The electrician was able to source some additional old lighting from his workshop and replaced.

The High Street Rec light column which was used in previous years to feed the power to the lights was no longer safe and had been turned off by contractors Balfour Beatty in the last year.

BPC will look into additional Christmas lighting for next year.

22/126. Boundary Reviews - West and North. (16)

Following the recent establishment of two new unitary councils for the Northamptonshire area, the Local Government Boundary Commission are asking residents to have their say on the new councils ward boundaries.

The commission has also announced that it is minded to recommend that the council should have 70 councillors in the future.

The Commission has not yet proposed any new wards but wants to know what residents think of the current wards and where you think new ones should be.

How to propose new ward boundaries:

Explain your opinion using evidence and examples.

Think about the three legal factors the Commission uses to draw new boundaries:

- 1. New wards should leave each councillor representing roughly the same number of voters as other councillors elsewhere in the authority.
- 2. New wards should as far as possible reflect community interests and identities, and boundaries should be identifiable. Consider transport links, community groups and facilities, natural or physical boundaries, parishes and shared interests.
- 3. New wards should promote effective and convenient local government. Consider the number of councillors for, the geographic size of, and the links between parts of the ward.

The Commission gives equal weight to all submissions, regardless of whom they are from. This stage of the consultation closes on 6 February 2023.

This work will inform the preparation of the North Northamptonshire Gypsy and Traveller Site Allocations Policy Development Plan Document (DPD).
