45/23. Reports from other meetings

Cllr Shrive contacted Evening Telegraph who are happy to help highlight Broughton's highways issues if needed.

Cllr's Shrive and Rose attended the NCalc training Planning workshop which was very good.

Cllr Scouse spoke to Steve Jubb (self employed planner employed by NNC) who is dealing with 13 G&T planning applications which include the Old Willows site NK/2021/0995.

A discussion took place regarding the net biodiversity gain claim from the applicant at Old Willows starting before the deadline which was disproved.

There is also a highways report on the embankment on the A43. A significant amount of work needs to be done before it subsides. It transpires it is difficult to hold an enforcement.

Safety concerns for the residents were raised.

46/23. Traffic Calming Report

Cllr Currall – Will now raise a complaint regarding the lack of response and action for the traffic calming measures due for Broughton via s106 money, further up the line after he received no reply again from Ian Boyes at Highways. Cllr Currall will also copy in the leader of NNC, Jason Smithers and Cllr Graham Lawman who is the portfolio holder.

Cllr Currall was asked who the staff in highways work for, NNC or Kier? Cllr O Hara confirmed she had asked the same question and confirmed both Simon Mills and Steve Barber (Road Safety Team looking after Kier) work for Kier.

The Interim Director at NNC is George Candler.

Matt O Connell is a Road safety officer and the go to for speed limits in the county. It was noted Broughton has been waiting for 2 years to have the agreed speed limit at Cransley Hill reduced to 40mph.

Police Report

54/23. Ward Boundaries Consultation

Reasons not to be with Rothwell

Criteria to be considered are:

- **Equality of representation.**

This means wards having roughly the same number of electors per councillor

- **Reflecting community interests and identities.**

1. Broughton, Mawsley & Cransley share church services.
2. Broughton & Mawsley provide convenience shopping, all other retail is in Kettering or beyond.
3. There is no public transport to Rothwell without first going to Kettering
4. Mawsley & Kettering provide primary medical services
5. Broughton, Pytchley and Mawsley have primary schools, many children will attend school in a neighbouring village e.g children from Mawsley attend Broughton Primary and vice versa. There will be a connection with families via school activities. Catchment for Rothwell Primary is only within the town. It's unlikely that many children from the villages would attend Rothwell.
6. Secondary school placements from the villages would largely be in Kettering.
7. Broughton, Pytchley and Cransley (Great Cransley and Little Cransley – now part of Broughton) are mentioned in the Domesday book and have always been largely agricultural villages. Rothwell, although having historic connections has always been a significant community with Roman connections and a Priory.
8. Families are integrated historically with Pytchley and Cransley, Great Cransley and Little Cransley

9. While there is no public transport to link the villages there are Public Rights of Way between Broughton – Pytchley, Broughton – Cransley - Mawsley

- **Providing for effective and convenient local government.**

1. Many issues would be common among the villages in the ward and would be better managed with one councillor representing the collective view.

2. In a rural ward it would be advantageous for the councillor to be known to local landowners and be familiar with rural matters in order to deal with issues affecting the rural community. Rothwell is a predominantly urban small town and would have little in common with the villages. With such a disproportionate number of urban voters there is a considerable risk that the villages would be side-lined and become an “after thought” with the time and effort of the ward councillors being targeted at the larger community.

Action: Clerk to submit to Local Government Boundary Commission for England

There is a very overgrown hedge that is protruding on to the pavement from a council property on the entrance to Glebe Avenue from Wellingborough Road.
